## Pathway to Selling Alcohol Safely Program **ORDER FORM**

The Pathway to Selling Alcohol Safely program is an all-inclusive CD-based and LMS training program that teaches employees and management the best practices when selling alcoholic beverages for off-premise and on-premise consumption.

The two-CD set includes a media-based presentation/training series and supplemental materials including lesson/review sheets, quizzes (with answer keys) and other subject resources.

This kit was initially created with funding by USDOT/NHSTA/FHWA in partnership with the Ohio Department of Public Safety and the Governor's Highway Safety office, and updated to include new ORC and legal guidelines as well as additional procedural information for industry best practices.

The Pathway to Selling Alcohol Safely program includes both Management and Associate training on the most important issues in alcohol sales for both on-premise and off-site consumption. Topics include: understanding current laws, what happens when law is violated, recognizing underage customers using false identification, and dealing with underage and intoxicated customers.
